## If you want to register or change the black

Step1.

Submit a notification to **Shizuoka Transport Branch Office**.



Step2.

Receive the issuance of 「事業用自動車等連絡書※」.

Perform the procedure at the Light Motor Vehicle Inspection Association.

## - Legal compliances required to achieve safe operations -

The following applicable laws and regulations have been put in place to ensure the safety of operations conducted by light cargo transportation business providers, so please strive to follow them in order to practice safe operations.

Front

### “Primary Safety Measures”

- Set working and driving hours that allow for taking sufficient breaks and rest, and comply with them.



- Cargo transport business notification.  
**Passengers cannot be transported!**



- Before driving, an alcohol checker should be used to check for inebriation. Confirmation that the driver is not ill or fatigued and a vehicle check should also be conducted. This information must all be recorded.



- Do not overload vehicles.  
When using a passenger car, the weight that can be loaded is (Riding capacity – number of passengers) x 55 kg.



- Enroll in voluntary insurance that covers cargo transport related damages.

Enroll in voluntary insurance



- Clearly display business name, and name or number on vehicles.



- Avoid loading cargo in such a way that it blocks the driver's view or interferes with vehicle operation (Road Traffic Act).

## - Legal compliances required to achieve safe operations -

When hiring drivers, in addition to the regulations on the front, the following measures must also be taken.

• When hiring drivers, a “roll call” that checks for driver inebriation, fatigue, and illness, as well as performing a vehicle check on all vehicles to be driven must be conducted as part of safety practices.



• Provide drivers with suitable instructions on not overloading cargo.



• Provide drivers with suitable instruction on safe operation practices and record the results.



These are only a few examples of “primary safety measures” that must be followed.
